Advanced Server-Side Scripting

Course Description:

Advanced server-side scripting skills and CMS utilization.

Course Focus:

This course will explore use of server-side programming languages to build dynamic, interactive websites and web-based applications using a Content Management (CMS) system. After the language and database review, basic knowledge of server-side languages will be used to explore Drupal, a commonly used CMS in the interactive design industry.

Quarter Credit Hour Definition:

Method of Instruction:

This course will include (1) lectures on topics in the required textbook and selected documents on the Internet, (2) lab work allowing students to apply concepts introduced during lectures, and (3) homework assignments which allow students to practice software and techniques introduced in class. Homework may include extra-credit options allowing students to go beyond the required programming techniques introduced in class. Homework from the previous week is presented in-class prior to the beginning of the lecture with basic and extra-credit options.

Students receive a weekly grade for their coursework consisting of (1) completed homework, (2) completed in-class assignments, and (3) credit for class participation, in particular researching or answering questions posed by the Instructor during the lecture.

Classroom Policy:

Attendance Policy:

The Art Institute of Campus is committed to learning-centered, hands-on instruction, which can only be accomplished when students attend class. There are no excused absences. The satisfactory explanation of an absence does not relieve the student from responsibility for the course work assigned and/or due during his/her absences. A student who does not attend class during the first week of school or starts late is still held responsible for his/her absences.

A student who is absent for three cumulative weeks* will be withdrawn from the course and will receive a Withdrawal (W) grade during weeks 1 through 9 of an 11 week term and a Withdrawal/Fail (W/F) grade after week 9 of an 11 week term for that course (after week 4 of a 5.5 week Mid-quarter ground term) unless the student submits an appeal to remain in class that is accepted by the instructor and department director/dean. A student is allowed only one appeal per class. In other words, if a student submits an appeal and it is approved, the next absence will initiate a non-appealable withdrawal from the course. The Attendance Appeal Request Form may be found in the Registrar's Office.

It is your responsibility to stay in communication with your instructor about absences in order to stay current with assignments. You are expected to spend the entire amount of scheduled class time in the classroom. If you are dropped from the class, you may have the opportunity to appeal. It is your responsibility to ensure that your attendance in class is brought to the faculty member's attention if you arrive late.

Students who are not marked present in any of their scheduled classes for fourteen (14) consecutive calendar days before the end of the ninth week of the 11 week term (week 4 of a 5.5 week Mid-quarter ground term), will be withdrawn from the Institute and will receive W's (withdrawals, with no grade penalty), or if the withdrawal occurs after the end of the ninth week of an 11 week term (after week 4 of a 5.5 week Mid-quarter ground term) students will be withdrawn from the Institute and will receive WF's (Failures due to late withdrawal). Calendar days include days that the student does not have any scheduled class. All calendar days that the school is not in session (e.g., school closings and holidays) do not count in the fourteen (14) calendar days as well during the active term. Students who have been withdrawn due to violation of the consecutive absence policy, but are still in good academic standing, if otherwise eligible, will be able to return the following term through the normal readmissions process. Students who have been withdrawn and the withdrawal results in a violation of the satisfactory academic progress policy (SAPP) must follow the procedure for appealing the academic dismissal.

Students are encouraged to make all schedule changes early in the first week of the quarter to minimize absences. Failure to sit in all classes during the first two weeks of school will result in termination from school for the quarter. Detailed information about scheduled adjustment periods can be found on the back of your official schedule or in the local Ai campus catalog.

If you are going to miss class, regardless of the reason, you should notify your instructor. You are responsible for gathering any information from the missed class period in a timely manner.

Ai Unearned F (UF) Grade Definition:

Unearned F Grade: students who failed the course AND did not complete the final assignments in the course. Final assignment include, but is not limited to a final exam, final project, final paper, portfolio

presentation, capstone project or any other assignment due in the last week of the course. If a student completed some or all of the other requirements in the course but did not complete the final assignment of the course and failed the course, the F grade will be considered unearned. An unearned F grade will be reflected as a "UF" grade on the transcript. The course's instructor will award this grade when appropriate.

Veteran Affairs Course Attendance Policy:

- Students who receive VA educational benefits are required to pursue each of their courses to be eligible for benefits. In order to receive the full benefit allowance the student must attend all classes in which the student is registered throughout the academic term at the campus.

Academic Dishonesty :

Cheating may include but is not limited to: copying the work of others; using notes or other materials when unauthorized; communicating to others during an exam; and any other unfair advantage as determined by the instructor.

If the committee determines that there has been a violation of the Academic Dishonesty policy, the student will automatically fail the class and, depending on the severity of the infraction, may face further disciplinary action up to and including suspension from classes or expulsion from school.

Weekly Outline

Monday, January 18th, Friday, February February 19th, and Friday March 25th are Campus Holidays. No classes are scheduled.

Lab: Explore Drupal and Drupal based CMS systems. PHP and MySQL review.
Homework: Set up Drupal on your host. Set up a local PHP/MySQL LAMP installation suitable for the CMS project.
- Week 2:** **Lecture:** Content creation. Input formats, Drupal content list & filtering content. Theming the homepage and inner content pages. Understanding Blocks. Continue on theming the pages. Taxonomy and taxonomy images. Path_auto, working with Drupal URLs. Linking to pages & images in the theme. The menu navigation system, setting up menus. Using the menu_block module. Set up the site menu, and footer menu. .
Lab: Create basic Drupal site. Planning a Drupal site. Information Architecture (IA) review. Content taxonomies in Drupal.
Homework: Complete basic site work in Drupal according to assigned taxonomy.
- Week 3:** **Lecture:** Using the CKeditor module. Creating custom headers and styles for the editor. Configuring the editor, working with Module Permissions. IMCE and IMCEimage modules for easier image handling in content. Updating modules, running cron. Using modules to set up forms, and blogs.
Lab: Develop in CMS using modules.
Homework: Develop concept for Midterm Project.
- Week 4:** **Lecture:** What the heck is a node? A look at the database, nodes and node revisions. Creating different node types. Tracking nodes, tracking revisions. Using the theme template file for custom functions. Customizing node pages, and other node types. Pulling in video and audio content using Embedded Media field, Flashnode, and Audio modules.
Lab: Develop in CMS using nodes, apply revision system to document update history.
Homework: Prepare for Midterm Presentation of site.

- Week 5:** **Lecture:** none
 Lab: Midterm Presentation.
 Homework: Develop Final Project Information Architecture (IA) Proposal.
- Week 6:** **Lecture:** Developing custom modules - intro. Drupal's hook system. Hooking into the permissions and menu. Including styles, JavaScripts and other files into the module. Programming a custom block. Delving into the menu API a little deeper. Calling functions. Passing arguments to pages. Hooking into the theme function.
 Lab: Work with the Drupal "hook" system
 Homework: Begin work on Final Project.
- Week 7:** **Lecture:** Working with the Form API. Validating & submitting forms. Creating and theming custom template files. Building an admin tool for custom module. Using Drupal's table API, pagination tools, and pulling things together.
 Lab: Create forms using the Form API.
 Homework: Continue work on Final Project.
- Week 8:** **Lecture:** Continue on from last week with Module Development, Form API, processing forms. Creating custom node types programmatically. Using JavaScript & JQuery with Drupal.
 Lab: Apply JavaScript and JQuery to Drupal.
 Homework: Continue work on Final Project.
- Week 9:** **Lecture:** Creating custom hooks, and filters.
 Lab: Final Project Review
 Homework: Continue work on Final Project.
- Week 10:** **Lecture:** Other CMS systems.
 Lab: Work on Final Project.
 Homework: Complete Final Project.
- Week 11:** **Lecture:** none
